Vendor Guidelines

Hillbilly Daylilies is proud to announce their third annual Bloomin’ Bash on **Saturday, July 9, 2011 from 9:00 am to 5:00 pm** to benefit the Berkeley County Humane Society. Hillbilly Daylilies is located on Giles Mill Road in Bunker Hill, West Virginia. There will be a \$10.00 entrance fee, children 6 – 12 \$5.00 and children under 5 free. This event will feature the following activities:

- Free Educational Workshops—garden related topics
- Free Children’s Activities—fun garden projects & crafts, face painting, and more
- Live Music
- Display of Antique Tractors & Steam Engines
- Food/drink concessions
- Vendors

1. Bloomin’Bash will be held each year on the same weekend in July to showcase a spectacular display of daylilies in peak bloom at our farm AND to provide educational workshops to all ages.
2. The event will be publicized in the Tri-State Area by way of newspapers, flyers, radio, and other organizations including Martinsburg-Berkeley County Convention & Visitors Bureau, Berkeley County Humane Society, and WV Department of Agriculture.
3. Artists, Crafters, Businesses and Nonprofit organizations are welcome to participate upon approval of qualification. We request that all products for sale be garden or nature related, handcrafted, and of high quality. We reserve the right to request verification of merchandise through business websites, photos, etc.
4. All vendor spaces are 10 x 10. Vendors must provide tent, tables, and chairs. All vendor spaces are located on grass. No electricity will be provided.

5. Vendor Space Fees:

- Artists, Crafters and Businesses: \$50 per 10 x 10 space
- Nonprofit organizations: space is free [if selling items, space is \$20]

6. Important Dates:

- May 13 Contract with space fee must be postmarked by this date.
- June 1 Cancellation deadline. Notification must be submitted in writing by this date to receive full refund of space fees.
- July 8 Set up Friday evening 5:00 pm to 8:00 pm
- July 9 Set up Saturday morning 6:00am to 9:00 am. Set up must be completed by 9:00 am.
- July 9 Breakdown after 5:00 pm only

Vendor Contract

1. Hillbilly Daylilies will hold a "Bloomin' Bash" on July 9, 2011 from 9:00 am to 5:00 pm. Vendor/Exhibitor participation is by invitation only and this Event will be held rain or shine.
2. All vendor spaces are 10' x 10' and located on grass. Vendors must provide their own tents, tables, and chairs. Exhibits and sale items must remain confined to the assigned area. No pets will be permitted.
3. Vendors may set up Friday, July 8 from 5:00 pm to 8:00 pm. Set up may also occur Saturday, July 9 from 6:00 am to 9:00 am. Set up must be completed by 9:00 am. All trailers and vehicles must be moved to designated area by 8:45 am July 9.
4. Vendor agrees to remain open until 5:00 pm July 9. After 5:00 pm, Vendor may begin to break down. All Vendor materials must be removed by 9:00 pm.
5. Each Vendor space will be allowed two admissions to the event. If any Vendor requires additional admissions, this must be agreed upon in advance.
6. Vendors agree to permit photographs and video to be taken of their booths and their products at the Bloomin' Bash, to be used for the purposes of promoting and advertising the Event.
7. Vendors agree to abide by all applicable laws, ordinances and regulations pertaining to health, fire prevention, public safety, business licenses, sales tax permits, and applicable liability insurance.
8. The Vendor agrees to indemnify and hold harmless Hillbilly Daylilies, its agents, and employees from any and all claims, causes of action suits, damages, theft, injuries and losses to any person or goods arising out of or connected in any way with the renting of space at the Event.
9. Vendors who are unable to participate in the Event for any reason must provide written notice to Hillbilly Daylilies by June 1, 2011 to receive a refund of space fees.
10. Vendor agrees to maintain dignity and integrity of the Event and will not perform any acts of a harmful nature. Hillbilly Daylilies reserves the sole right to ask any Vendor or its employees to leave the Event whom they feel are not acting in the best interest of the Event.

11. This agreement constitutes the entire contract between Hillbilly Daylilies and the Vendor. No changes shall be valid unless agreed upon by both parties in writing.
